

**RESOLUTION NO. 13-06**

**RESOLUTION TO AMEND PROPOSED METERED RATES  
RESOLUTION NO. 13-02**

**WHEREAS**, the Esparto Community Services District (ECSD) Board of Directors approved Resolution No. 13-02 at the meeting of February 6, 2013, and

**WHEREAS**, the ECSD Board of Directors wish to amend the proposed rates called out in Resolution No. 13-02, and

**WHEREAS**, Article XIIIID of the California Constitution and the laws enacted in connection therewith provide that prior to the public hearing to adopt a formula for adjusting water rates, ECSD must mail to each property owner or customer, subject to the fee, at least 45 days prior to such public hearing, a copy of said formula for adjusting water rates.

**NOW, THEREFORE , BE IT RESOLVED** the ECSD Board of Directors hereby approves the following **amended metered rate fee structure** to be distributed to each property owner or customer, within the ECSD boundaries, at least 45 days prior to convening the public hearing to adopt said **amended metered rate fee structure**.
