# (6) APPROVE ADDITIONAL ASPHALT COST TO COMPLETE PARKING LOT BY EATON GRADING

General Manager explained the problem with the parking lot and the reason for the additional cost. During excavation a water line was hit and had to be repaired. Do to the elevation issue, the pipe and drain had to be raised 3 ½ inches and instead of using cement pipe, plastic was used.

6:09 pm: Director Colleen Fescenmeyer arrived.

Eaton reviewed the parking lot and noted some additional discrepancies. The additional cost to make the correction would be \$19,000. However this cost could be reduced to \$14,867 if we remove the surrey seal. It was noted the asphalt could last

7-8 years without the seal. Discussion followed regarding adding the cost of the surrey seal process to a future Budget.

General Manager Steve Knightley indicated we want to have this parking lot done right as it has been a problem for some time.

Chair Charles Schaupp indicated the board would remain in open session, and move outside to inspect the parking lot. Upon returned any concerns or comments by the board will be stated for the record.

6:30 pm: Board returns from viewing parking lot progress.

Chair Charles Schaupp indicated the board looked at the grade, where asphalt to be poured, slab for ADA compliance, the drain and the road. A discussion was held regarding what the repairs would accomplish if approved.
