(9) WELL 3 OPTION TO DEVELOP TEST WELL TO PRODUCTION WELL

General Manager reported on the MCL test, water is clear, no chrome 6 present only a small amount of arsenic .00027. Aquafer is 100 ft. deeper. We now have wells at three different depths.

Vice Chair Colleen Fescenmeyer called for a motion to develop Well 3 for production

Motion by: Director Don England to develop the test well for production on Well 3.

Second by: Director Colin Crerar

Discussion: General Manager explained Eaton completed the test well and the water tests cleared for a production well. The original idea was to abandon the test well and wait until next year to budget the cost of converting Well 3 to production until the payment from Mercy Housing Phase 2 which has now been received; we now have funds in reserve for Well 3 development. The question was if we allow Eaton to do the conversion of test well to production well, it could save the district approximately \$160,000.00 to do it now vs. next year. General Manager went on to explain the difference between using stainless steel versus plastic and how it is a theory the high chrome 6 measurements comes from the stainless steel in the well pipe. Well 3 will produce 300 gal. Per minute and can be put on line in less than a month if we direct Eaton to develop the test well into a production well.

Eaton has always been the lowest bid and based on the significant savings to the district there is no concern regarding Eaton starting immediately to develop this well for production. General Manager is to inform Eaton to begin immediately. Some discussion followed.
