- (2) For each Single Family occupying a dwelling equipped for housekeeping, and the ground area for which, including area occupied by structure, and does not exceed a 7500 square foot lot-----\$35.64

(3) For each Single Family occupying a dwelling equipped for housekeeping, and the ground area for which, including area occupied by structure, and does not exceed a 15000 square foot lot-----\$38.60

(4) When authorized, water used on an additional 2500 square foot lot or portion thereof-----\$ 5.94

(b) Other Rates

- (1) VFW Building.....\$14.81
- (2) Small Business.....28.28

To be calculated on an individual basis once the District has parameters and calculations on amount of water from an Engineer.

SECTION 4. DISCONNECTION AND RE-CONNECTION

In the case of water shut off for non-payment or delinquent balances, the water shall Remain off until all the arrears and disconnection and reconnection charges are paid in full.

Resolution No. 08-03

RESOLUTION ESTABLISHING WATER AND WASTEWATER SERVICE RATES

WHEREAS, the Board of the Esparto Community Services District (the "Board") finds as follows:

1. The Esparto Community Services District (the "District") provides water and wastewater services to its citizens;
2. The District charges customers of these utilities a charge to fund the operation and maintenance of the water and wastewater services (the "Utilities");
3. District staff have reviewed the operation of the Utilities and has found that major capital improvements are necessary;
4. Based on the cost of these capital improvements, District staff recommends increases to the current water and wastewater rates;
5. The Board directed that notice of a hearing thereon be given to the property owners and ratepayers in the District, with such notice to include, among other matters, the information required to be included pursuant to California Constitution Article XIII D section 6;
6. Such notice has been mailed to those parties, at least 45 days before the hearing, as evidenced by a Certificate of Mailing on file with the District Clerk;
7. On January 9, 2008 the District Board conducted said public hearing at which time the District Board heard all objections and protests to the proposed increased rates;
8. Written protests against the proposed increased rates were not presented by a majority of the interested parties; and
9. The proposed water and wastewater service rates do not exceed the costs reasonably borne by the District in providing the services, comply with the provisions of section 61123 of the Government Code, and are in compliance with all other applicable law.

NOW, THEREFORE, BE IT RESOLVED by the Board of the Esparto Community Services District, that:


Section 1. Recitals. The foregoing recitals are true and correct.

Section 2. Levy of Charges. The increased water and wastewater collection service rates as attached hereto as Exhibit "A" are hereby approved.

Section 3. Effective Date. This resolution shall take effect from and after the date of its passage.
